The Officer-in-Charge of the Strategic Communications Division of the Department of Public Information briefed the Committee on the activities undertaken by the Department in the past year with regard to the dissemination of information in the field of decolonization.

The Chief of the Decolonization Unit of the Department of Political Affairs reviewed the activities of the Department in the field of dissemination of information on decolonization over the past year.
